The year that was

Key Results Achieved:

- 1) Fifteen residents, were inducted from Government Mental Hospital, Eight were rehabilitated with their families.
- 2) Thirteen ex-residents, who were discharged earlier, relapsed due to reasons like not taking medicines and negligence of the family members, were treated for various duration and were sent back to their respective residents.
- 3) Ten mentally ill patients inducted from lower middle class families were treated and Ten were rehabilitated with their families under the Short-stay Programme.

The average occupancies was 30 out of 30 beds

4) Received the State Award 2024, as the Best Organization by the Dept. of Persons with Disabilities, Ministry of Social Welfare, GoWB for Outstanding Performance in Rehabilitation of Persons with Disability, to Paripurnata, in 2024.



5) Donation from well-wishers & corporate houses has increased from ₹50.1 Lakhs to ₹74.₺7 Lakhs.

Activities carried out:

Rehabilitation -

The ongoing residential programme of *Psycho-social Rehabilitation of Mentally ill Women* was conducted simultaneously in three streams :

- i) Rehabilitation programme of 9-12 months for women belonging to the marginalized sections, inducted from Calcutta Pavlov Hospital.
- ii) Rehabilitation months for our ex-residents, who have relapsed, due to factors like, not taking the prescribed medicines and negligence / ill treatment by family members.
- iii) Short stay programme of 4-6 months for women belonging to lower middle class families.

Therapy -

Pharmaco – therapy: Psychiatric treatment with psychotropic medicines as required were regularly carried out by the psychiatrist.

Psychological counseling : Psychological counselling were rendered to all the residents, as applicable. Periodic group therapy sessions and mental state examinations were conducted periodically.

Physical check-up: A general physician regularly carried out check-ups of all the residents and if required prescribed diagnostic and clinical examinations.

Occupational therapy: Training in basic domestic skills like, cleaning, washing, personal hygiene and grooming were imparted every day. Training sessions on stitching, sewing and block printing were held as planned.

Socio-cultural therapy: Therapies in the form of music, dancing, painting and yoga were imparted as planned. To inculcate social skills like, receiving visitors, social interactions and shopping etc. were conducted regularly.

Non-formal education: Classes on general knowledge, current affairs, storytelling and basic human rights were held.

PARALLEL ACTIVITIES CARRIED OUT

Home Visits: Visiting the families of the beneficiaries is an integral part of our rehabilitation process, which help us to gain first-hand knowledge on the ambience of the family and the community; & accordingly sensitize them. Visits were also made to the homes the ex-residents as follow-up measures. A few visits were accompanied by Managing Committee Members also. During the FY 2024-25, 36 such families were visited.

Rabindra Jayanti: 164th Birth Anniversary of the poet Rabindranath Tagore was observed on 9th May 2024 in our Auditorium. The programme began with rendition of Rabindra Sangeet by the Residents. This was followed by a Cultural Programme. The residents paid homage to the poet by reciting poems, singing Rabindra Sangeet and performing dance numbers, composed by him.



Observing World Schizophrenia Day: Schizophrenia day was observed by Paripurnata in association with **FORTIS HOSPITAL**. A Medical Health Camp was organized on 24th May 2024. The residents, staff and instructors had undergone medical check-up (Blood Sugar, Blood Pressure, ECG, Lung function test, followed by doctor's advice), all the residents were benefited by the camp. All together 45 participants were there.

Condolence Meeting on 7th June 2024 at our auditorium to pay homage to the memory of our beloved Sailen Kumar Ray our Ex-President in the year 2016-17 & 2017-18.

28 persons of Paripurnata family were present on this occasion. They expressed their homage and good experience.

Observing International Yoga Day:

A Programme on Yoga was organized on 21st June 2024 at Paripurnata. Ms. Malobika Saha Bhowmick, Yoga Therapist of Paripurnata conducted the programme along with the beneficiaries of Paripurnata. Mr. Bidhan Chandra Chakrabarti, Hony Secretary of Paripurnata gave a brief lecture on importance of Yoga in our life. Mr. Briti Sundar Bhattacharjee, Psychiatric Social Worker anchored the Programme. Two types of Yoga were performed by the beneficiaries of Paripurnata, along with Ms. Malobika Saha Bhowmick. Vote of thanks was given by Ms. Jhuma Bhatta, Programme Coordinator-cum-Psychologist. The duration of the programme was 1 hour and nearly 40 persons attended the programme. Programme ended with light refreshment for all participants.



Doctor's Day: Doctors Day was observed by Paripurnata in association with Group of Doctors led by Dr. Swapna Majhi on 30th June 2024, Medical Health Camp was organized for residents. Medical Health check-up like Blood Sugar, Blood Pressure, ECG, Lipid Profile test, followed by doctor's advice. All together 30 beneficiaries' were there and all of them were benefited by the camp.

Awareness Programme:

An awareness programme of psychosocial-education to the Community was organized on 10th July 2024 at Mahendra Nagar, Sodepur, North 24 Parganas, near the house of our ex-resident, Smt. Rama Das. The programme was conducted by Smt. Jhuma Bhatta, Programme Coordinator cum Psychologist and Shri B.S. Bhattacharjee, Psychiatric Social Worker. The 2 hour session was attended by about 50 persons. The audience was made aware of the history of Paripurnata and its approach to the rehabilitation process.

The topics included:-

- 1. Introduction to positive mental health.
- 2. Symptom & causes of mental illness.
- 3. Precaution & prevention.
- 4. The role of the community.

The community was requested to accept the persons suffering from mental illness with grace and to spread awareness about the illness to their kith and kin.



On 12th March 2025, a team from Paripurnata, comprising of Jhuma Bhatta (Psychologist), B.S. Bhattacharjee (P.S.W.), Sandhya Chakraborty (Assistant House Mother), Gautam Chatui (Peon), and two twin sisters named Ganga & Jamuna, visited Gobrapur village in Bongaon, 24 Parganas North. The purpose of the visit was to conduct an awareness program within the community regarding mental health issues and to eradicate the stigma associated with mental illness. The team arrived in Gobrapur village at approximately 5:00 p.m. The venue for the awareness session was chosen as it is the home village of two of the residents of Paripurnata.



The focus of the program was on raising awareness about mental health, including the causes, signs, symptoms, prevention, and treatment of mental illnesses.

About 45 to 50 villagers attended the programme. The local people, along with the key community leaders, showed great interest and supported us throughout the session.

Celebration of Foundation Day of Paripurnata:

Celebrations of 33rd Foundation Day of Paripurnata held on 8th August 2024 was kicked off with the Cake Cutting Ceremony at our Sovarani Sil & Banamali Sil Memorial Hall. in which the beneficiaries and staff members participated. Mr. Bidhan Chandra Chakrabarti delivered short speeches on our struggle and History of Paripurnata also Shri Briti Sundar Bhattacharjee gave a vote of thanks to the audience.



Independence Day:

The 77th anniversary of our Independence was celebrated on 15th August 2024. The celebration commenced with hoisting of the national flag by our resident Ms.- Nilanjana Talukdar. The residents confidently rendered nationalistic songs & recitations, dance drama. Mr. Bidhan Chandra Chakrabarti delivered a short speech on our freedom struggle and Shri Briti Sundar Bhattacharjee gave vote of thanks to the audience.



Musical Soiree:

A musical soiree organised by Musical Finger, for our residents was held on 7th October 2024, on the occasion of *International Mental Health Week*. Ms. Shanoli Sen, (Founder of Musical Finger) and her students performed the soiree and our residents also enjoy the programme at our auditorium.



Durga Puja Colobration

On *Maha Sasthi*, 9th October 2024, the resident accompanied by the staff members, visited in a chartered bus some of the famous puja pandals in Narendrapur, Garia and Baisnabghata – Patuli area. Refreshment was served during the trip.

They enthusiastically took part in the various organized programmes. A wholesome Breakfast and Lunch were served.



House staff meeting: A meeting for house staff was held on 29th January 2025, in which 7 House Staff members and Programme Staff attended the meeting. Our Hony. Secretary Sri Bidhan Chandra Chakrabarti presided over the meet. Various issues and problem area which were thoroughly discussed and resolved in amicable manner. Tea and Samosa were served after the meeting.


